Specimens will be considered to be kept in contained holding if the following conditions are fulfilled:

- \* the specimens are physically isolated and they cannot escape or spread or be removed by unauthorized persons from the holdings where they are kept;
- \* cleaning, waste handling and maintenance protocols ensure that no specimens or reproducible parts can escape, spread or be removed by unauthorized persons;
- \* the removal of the specimens from the holdings, disposal or destruction or humane cull is done in such way as to exclude propagation or reproduction outside the holdings.
